- i. Self-certification for hardship withdrawals
  - Alice Krueger brought up the self-certification for hardship withdrawals. Members are all in favor of adopting self-certification for hardship withdrawals but expressed concern about participant abuse. Brent Petty commented that self-certification shifts the responsibility/liability from the County to the participant and lessens the administrative burden. Item to be added to the June meeting agenda for vote to recommend action.
- ii. Domestic violence withdrawals
  - Alice Krueger discussed the domestic violence withdrawals provisions. Members are all in favor of adopting domestic violence withdrawals. Item to be added to the June meeting agenda for vote to recommend action.
- iii. Age 60-63 catch-up maximum increases
  - Alice Krueger discussed the age 60-63 catch-up maximum increase provision for 2025 implementation. Members questioned the administration cost for implementation. Members are all in favor as cost is not substantial. Item to be added to the June meeting agenda for vote to recommend action.
