Important Information on Your 2021 Open Enrollment Elections



We would like to present a double opportunity to **increase the amount of your County take home pay by thousands of dollars** with no change in your traditional doctors, hospitals and/or prescription drugs.

The first opportunity you have to increase your take home pay is to make a choice to increase the amount the County contributes to your medical coverage. As a Tier A employee, your County of Sacramento employer contribution toward your medical coverage is frozen, and is far less than the contribution provided to Tier B employees when choosing family coverage. By moving from Tier A to Tier B, **you could receive thousands of dollars more in your taken home pay.**

Your second opportunity to increase your take home pay is to make a choice to move from a traditional HMO plan to a High Deductible HMO plan. The three County sponsored medical carriers each offer a traditional \$15 Health Maintenance Organization plan (HMO) and a High Deductible Health Plan (HDHP). HDHPs have lower monthly premiums than traditional HMO plans but have a larger initial out of pocket deductible expense for services if/when you need care. If you elect to move to a High Deductible plan, you will receive thousands of dollars more in your taken home pay while capping your annual deductible expenses at \$2,800 (plus your per pay check deductions). By completing both actions during the upcoming Open Enrollment, you will be investing in yourself and your future.

The following chart shows your potential savings:



HDHP enrollment might also allow you to contribute to a Health Savings Account (HSA) under certain conditions to protect you from the deductible costs and help with retiree health cost.
