

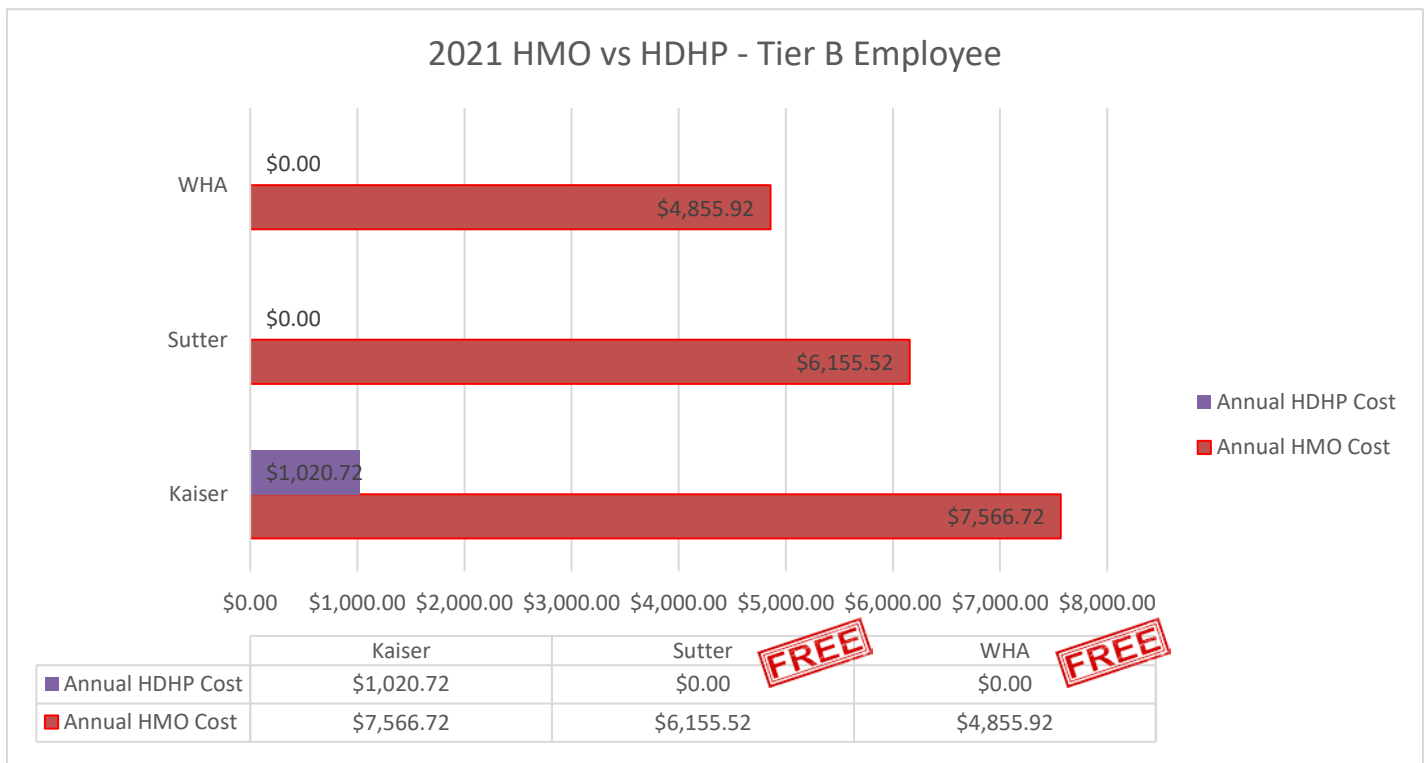

Do you know the savings difference between a HMO and a HDHP plan?

The County offers three (3) traditional Health Maintenance Organization plans (HMO) and three (3) High Deductible Health Plans (HDHP). HDHPs have lower in monthly premiums than traditional HMO plan but may have a larger out of pocket expense for services which you pay at the time of care. The following chart shows your potential savings.



HDHP enrollment might also allow you to contribute to a Health Savings Account (HSA) under certain conditions to protect you from the deductible costs and help with retiree health cost.

To help you learn more about how you can **save thousands of dollars** and increase your pay in 2021, we have set up a number of virtual informational sessions.
