The 24/7 Behavioral Health Crisis Call Center and Response Team will be a combination of Health Program Managers, Program Coordinators, Senior Mental Health Counselors, Mental Health Counselors, Peers and an administrative team including: Office Assistant Level 2, Senior Office Assistants, an Administrative Officer I, and Administrative Services Officers II.

**Job Title: Behavioral Health Peer Specialist** – provides peer support such as sharing recovery stories, identifies wellness goals, and provides emotional support to consumers of behavioral health services and their families. In partnership with a clinician, provides in-person response as part of the Response Team.
